3. Approve Minutes Of The Last Meeting

The Minutes of the meeting on the 10th June 2007 were accepted as a true record.

4. Regional Council Funding

4.1. Agree Actual Regional Council Expenditure Year Past (see Appendix 1)

- a. Agreed expenditure for CCC was £408.88 (2007). Previously paid £497.02. New balance £88.14.
- **b.** Agreed expenditure for CNCC was £610.23 (2007). Previously paid £817.49. New balance £207.26.
- **c.** Agreed expenditure for DCUC was £1.25 (2006), £10.00 (2007). Previously paid £244. New balance £232.75.
- **d.** Agreed expenditure for DCA was £1037.61 (2007). Previous balance £0. DCA due £1037.61. Action DC
- e. No scrutinised accounts were available from CSCC for 2006 or 2007.
- **f.** It was noted that CCC's Cave Wildlife Website and CNCC's Skoska Moth Monitoring project were not core-funding however BCRA grants might be available instead.
- **g.** CCC is proposing to move to an accrual basis for the benefit of the Welsh Sports Council (SCW). The anticipated BCA funding will be accrued.
- **h.** It was noted that each Council present their accounts in the format of their choice so long as all the information is present.
- i. DCUC to be refunded £50 insurance overpaid in 2006. BCA stopped charging Regional Councils insurance from 2006.

- **b.** It was noted there might be access bodies in other regions eligible for funded status.
- **c.** Subject to the agreement of the Insurance Manager and National Council it was agreed not to charge the FABs the £50 BCA insurance. **Action DC**
