# **British Caving Association How to book onto a course**

### **Register with scheme**

All candidates wishing to book onto a training or assessment course must be registered with the LCMLA & CIC award scheme. Candidates need only register once, for which there is a one-off fee for both the Local Cave and Mine Leader Award and Cave Instructor Certificate schemes. To register;

### Register for a course

Courses are delivered by Trainer/Assessors following the award scheme syllabus. Trainer/Assessors must register all courses with the Qualification Management System (QMS), however in some cases may choose not to advertise the course publicly on the system.

Candidates can only book onto a course if the pre-requisites are met.

## **Book onto a course through the Qualification Management System**

- Find a course
  - Click on Events & Courses
  - Select course type then region
  - Select a course
  - Click "Add to cart" (note in most cases candidates are unable to book onto a course if they do not meet the pre-requisites)
  - Follow the payment method, even though the payment will be zero, and complete the order

### Book onto a course direct with a Trainer/Assessor

If booking directly with a Trainer/Assessor, or for courses not advertised on the system, candidates will need to provide the following details (in the same format registered with the QMS) to the Trainer/Assessor so that they can add candidates to the course:

- First Name
- Last Name
- Membership Number (note this starts with ME)
- Date of Birth

In both cases, once booked onto a course the Trainer/Assessor will contact candidates with joining instructions, booking conditions and invoicing details.

Please be aware that Trainer/Assessors may remove candidates from a course if the Trainer/Assessors bookings terms and conditions are not met.



### British Caving Association Vertical Cave and/or Mine Leader Training

Training course for those wishing to lead groups in vertical terrain within the Caves/Mines listed under their Cave and/or Mine Leader award. The Vertical Leader is limited to simple vertical pitches of no more than 18m in length, including more technical traverses.

### **Update Cave/Mine Leader via Training**

Cave and/or Mine Leaders may update their current qualifications if attending a Vertical Leader Training course provided the appropriate pre-requisites are met and evidenced prior to the course. Candidates who wish to update their award via this route need to complete an <a href="experience summary">experience summary</a> and submit it to the Trainer/ Assessor delivering the Vertical Leader Training course at least 2 weeks before your course.

#### **Pre-requisites**

Candidates must have completed their Cave and/or Mine Leader training course prior to attending this course. A degree of SRT competence is also required. A minimum of 12 vertical trips although at the discretion of the Trainer a candidate can be accepted with less experience.

#### **Course Overview**

This largely practical training course would take place over a minimum of 2 days involving both surface and underground sessions. At least 6hrs of the training course should be spent underground. Up to 4 candidates may attend this course with one Trainer/Assessor. The course is recognized nationally, and so can be attended in any region. Candidates are expected to be comfortable exploring vertical caves and mines with some SRT competence, although an element of SRT training will be included in the course.

Training courses will focus on some personal skill development however will primarily focus on the specific skills required by a leader to manage a group in vertical terrain through both abseil and ladder, including an understanding of incident prevention and management.

The training course will cover the key areas of the assessment syllabus listed below, with a tailored focus on areas candidates typically have difficulty with or identify with the Trainer/Assessor as requiring further input. QMC have prepared some resources that may support a candidate, these are available on the BCA website.

Trainer/Assessors may offer resources and guidance for a candidate to help further their knowledge however candidates are encouraged to familiarize themselves with

### Your next steps

Following the training course candidate's pathway to assessment may vary depending on their current qualification. Those with a valid Cave and/or Mine Leader Award may present for a Vertical Leader Assessment, followed by a Vertical Group Day Assessment.

Candidates who have only completed their Cave and/or Mine Leader Core Skills Assessment will be required to complete a Vertical Leader Core Skills Assessment, however, may choose to combine their Cave and/or Mine Group Day Assessment with their Vertical Leader Group day assessment. In such cases candidates would be expected to exceed the minimum pre-requisite experience, with combined assessments at the discretion of the Trainer/Assessor.
